146/21 CHAIR - ELECTION OF

Nominations for the position of Chair of the Committee were invited, and it was

RESOLVED UNANIMOUSLY

Apologies were received from Councillor Ham. Councillor Dorrance informed Members that he would have to leave the meeting at 6:30pm due to a meeting clash.

151/21 FISHING

As Councillor Dorrance declared an interest in this item, he was placed in the waiting room, and took no part in discussion.

The Town Clerk informed Members that she had received a request from Dixies Corner to sell fishing tickets on behalf of the association, as they are about to start selling a fishing range. After discussion, it was

RESOLVED

156/21 BRYNAWELON PARK UPDATE AND BUDGET CONSIDERATION

The Town Clerk provided Members with a verbal update regarding Brynawelon Park, by way of confirming that she had received notification from officers at Dering Lines that they have successfully secured funding for the park to be updated. The Town Clerk confirmed the budget allocated in this year' precept for this project could therefore be reallocated.

RESOLVED

THAT this information be taken as received and noted.

157/21 PRIORY GROVES PARK

Councillor Dorrance gave a verbal overview of this agenda item, and informed Members that the land at this site is owned by the Church in Wales, but is on a long term lease to Powys County Council. Residents

have raised concerns about the lack of equipment and facilities at the park, and Powys County Council are not able to invest at this location. Members raised queries about the age of the users of this park, and ownership responsibilities, along with grant options. Councillor Dorrance confirmed he is exploring other funding streams and requested consideration of reallocation of the Brynawelon budget as part funding for this project. After discussion, it was

RESOLVED

THAT the Brynawelon budget is reallocated to this project, and that the Environment Act Working Group consider the project in further detail.

158/21 FREE PARKING

Submitted **E(E)** information relating to the free parking. Members discussed this in detail, and it was

RESOLVED

THAT the free parking agreement be extended as noted within the report.

159/21 BRECON WITH BELLS ON

The Town Clerk informed Members that a decision will need to be taken fairly soon in relation to whether Brecon With Bells On is able to safely go ahead in 2021, and suggested that this is reviewed following the next Welsh Government announcement due next week, though recommended that a decision is taken before the next meeting of this Committee to allow sufficient time to plan the event if it is able to go ahead. Councillor Rijnenberg informed Members that the Lions Club had donated a planter for the bus station area, and that the Brecon Rotary Club had offered £400 for an additional planter to be placed at the bus station. It was queried whether the Park Keeper could be asked to create a planter in similar style as the ones on the Bulwark, with match funding from this Committee.

The Town Clerk informed Members that a tree at Camden Road Park needs removing as it is dead. It was suggested that a replacement could be looked at within other projects.

Councillor M Davies informed Members that she had been doing some research into buskers and street entertainers for a proposal to bring back to this Committee and sought permission to form a Working Group, consisting of Councillors M Davies, M Matthews, L Rijnenberg, and J Powell, which was agreed.

Mr M Rich raised a concern about leaning traffic lights and lamp posts in the town, and asked who this concern should be raised with. Councillor Rijnenberg confirmed she will look into this with the highways

department at Powys County Council, and it was also agreed to send a letter from this Committee to request that this be addressed.
