#### Audit opinion - Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

#### Accumulated reserves

We note that the Council's retained reserves have been steadily increasing over the last five years and as at 31 March 2022 stood at £398,794. These balances include earmarked reserves held for specific purposes. However, our audit identified that some of these earmarked reserves are static.

We recommend that the Council reviews its level of reserves in 2023-24 to ensure it does not hold reserves without a specific purpose.
